- In addition, administration will contact faculty members to collect relevant information regarding the appeal.

## Typewritten Letter Instructions:

In your typed appeal letter, please address the following questions.

- 1. What extenuating circumstances affected your performance and why were you unable to meet the minimum standards of program hours or classroom behavior? Be specific.
- 2. How do you plan to improve your performance if you are allowed to continue in courses with Fort Hays Tech | Northwest?
- 3. Describe any additional information you feel is relevant to the appeal.

Items that administration will consider for the appeal include, but are not limited to:

- Student's academic performance in the program and related courses.
- Student's attendance and tardiness in the program and related courses.
- Student's behavior in the program and related courses.
- Support items submitted by the student.

## Additional Instructions for Suspension Appeal

- 1. If you have already enrolled in courses for an upcoming semester, your courses will be held until your suspension appeal has been decided.
- 2. As soon as a decision is reached, administration will notify you of the outcome of your appeal by email to your Fort Hays Tech | NW student email account. It is critical during the suspension appeal period, that you monitor your email regularly in case additional information or meetings are requested.
- 3. If your appeal is denied, your courses for the upcoming semester will be dropped.
- 4. Students who are not enrolled in a minimum of 12 hours are not permitted to remain in campus housing, and must vacate the college dorms within 24 hours.
- 5. Submit your appeal in person or by mail as follows:
